Earth Justice Introduction

- An environmental organization is an organization coming out of the conservation or environmental movements that seeks to protect, analyze or monitor the environment against misuse or degradation from human forces. In this sense the environment may refer to the biophysical environment or the natural environment.
- Earthjustice is the premier nonprofit public interest environmental law organization.
- They wield the power of law and the strength of partnership to protect people's health, to preserve magnificent places and wildlife, to advance clean energy, and to combat climate change.

Earth Justice

- Earthjustice is the premier nonprofit public interest environmental law organization.
- This organization was founded in 1971 , with the name " Sierra Club Legal Defense Fund", but in 1997 they changed it to " Earth Justice".
- Headquarter in San Fracisco ,USA.
- In 2018 the group provided free legal representation to over 1000 clients.

Earth Justice

- In 1993 , they filled a lawsuit to block the development of the new world gold-silver-copper mine that was planned to be situated about 4 miles from the northeast entrance to the Yellowstone National Park
- In 1998, Earth justice helped local community groups convince the U.S nuclear regulatory commission to withdraw an approval to build a uranium enrichment plant between two low-income, predominantly African-American near Homer, Luisiana. It was the first time government agency had formally embraced the principle of environmental justice.

Earth Justice Marketing/Finances

- Earth justice closed this last fiscal year on June 30 2021, with \$93 Million in funds raised from contributions and \$14 Million in bequests.
- They added over 27,000 donors to they're base of 100,000+ donors across the country.
- For the thirteenth year in a row, Earthjustice received Charity Navigator's highest rating of 4 stars an accomplishment achieved by fewer than 1% of all charities that Charity Navigator analyzes.
